Councilor McLean "and move to Option 1- Approval. Thankyou.

Now to **Councilor Breakey** – "I just like to say on Thursday the Provincial Agricultural Services Board is presenting on the value of ecological goods and service and our natural capital and one of the conclusions of the study was that Recreation has an equivalent or greater value per acre to the county than agriculture .You know, this is this is a good thing to be able to stay on the land, work with your neighbors as well as possible and bring value to the neighborhood and I'd like to support the motion."

Councilor Solberg – "I support the motion and has well, I really think that at some of the best use for this piece of land. There is no question in my mind at all from an economic perspective just on the County's point of view. It is more than likely least 50 times the tax base that takes us there today. We are not supposed to make our decisions based on economics, I guess, but I think it would be great for economics for the area part-time jobs for students and also for other people that would like some extra employment and I'll support the motion I think it's so the right thing to do in this particular location."

Councilor Magnusson – "Thank you for the chair. Well, I think this is a really interesting application. It has a lot of promise. Recreation, employment, it brings value to the area to a point, but I can't I just can't quite support it because I think the AG Service Board got it in a nutshell. It represents significant impact the local agricultural community and production; including traffic, dust, increased people, activities occur daily/nightly and potential water-well depletion. The intrusiveness of large numbers of non-local people, the need for appropriate buffering, etc. and we feel we haven't really dealt with the road. So, it's just a bit too early for me. I would like more conversations to happen. Although I do really like your idea."

Councilor Belkie – "Well, I'm going to support it. The AG Master Plan and the AG Service Board comments, frankly, baffle me a little bit is in so much as well what size of a proposal is appropriate? Should it be a little teensy weensy one that is implicated by that your report that may or may not have implications of profitability. Where sometimes a larger scale like this is kind of a twofold operation of golf course and a little Convention Center which has A+ financial effects or should have a positive financial affect there was an argument made about that. It could create future developments in and accountability around this golf course, there is potential always for something to happen, but the one that came to my mind and it's not a golf course, but it is a retreat down by Cochrane and I didn't see, haven't been there for years, any big push for any development around it? It's a little Retreat Convention Center that you can go to and the community doesn't seem to be burning about it. So, I'm going to support this."

Who's next? **Councilor Bahcheli**. – "Well, I cast the deciding vote last year and I had to go on the side of the roads, just couldn't take it and that's what pushed me over even though it was

50/50 all the way down the line on all the other considerations. My worst-case scenario is I think whatever Revenue the County gets out of this annually is going to be plowed right back into the local roads, but in a sense that's to the benefit of everybody because we can calcium the provincial Road and we can calcium our own Road and, so, the worst-case scenario is we're taking a strip out of counselor McLean's butt because we are putting calcium down on a really big stretch property. I wouldn't be at all surprised if that's what we end up doing but there is a solution and it's not as if it's a solution that doesn't cost a whole lot of money and it actually makes everybody happier. So, I am going to support the motion this year."

Anybody else? **Reeve Ashdown** – "Well, I am, I actually remember the last time that we had this I wanted to my comments short, I think I kept them fairly short, planning to do that again this year. I want to see what a rural golf course looks like.

I've actually golfed tooth of the dog or with a tooth golf course our way. I can remember the name of it, but it was a lot of fun and it was kind of in the middle of nowhere and I'm like really crappy golfer, so, it really didn't matter but it was, it was, a good place to go and it was a good afternoon and there was a lot of real friendly people there and I'm sure that's what this one is going to be, too and I'll bet you once we get a few things going on that people will get out to the country that maybe we can convince that the provincial government tax to get rid of the Dust because I know that that's been a the pictures of the best. We've been fighting on that ever since I got here and ever since I can remember to try to get the dust mitigated on 574. So, I'm hoping that this can actually do that. So, I'm going to support the motion too and I think it's a good one."

Councilor Sacuda – "You know my biggest concern is the impact of these roads and then the dust that is on them. I guess I'm willing to take a flyer that if the golf course goes it wraps to the provincial government will be a little more amenable to paving the road to get there because a golf course at the end of 10km of a gravel road is frankly a bad idea, but perhaps we can actually get some pavement in a suitable time because of it. I'm going to support the motion."

Reeve Ashdown – "Call the VOTE: Ok, we will start down there, Counselor Sacuda, we need a recorded vote. How do you vote? in favor, opposed, in favor, in favor, in favor, opposed, in favor, and that was CARRIED Second Reading.

Thank you for your email of October 27, 2011 regarding your concerns for the safe operation of the intersection of Highway 22 and Township Road 290. I have discussed your concerns with my colleague, Honourable Ray Danyluk, Minister of Transportation, and am pleased to provide the following information.

Minister Danyluk advised that he has asked his staff to hire an engineering consultant to undertake a safety review of both the Township Road 290 and the Highway 574 intersections on Highway 22. It is expected this review will be completed in early 2012. The implementation of any recommendations from the review will depend on funding availability.

In regard to paving Highway 574 east of Highway 22, Alberta Transportation receives far more requests, throughout the province, to pave gravel highways than there is funding available for this type of work. Annually, the department reviews all potential paving projects by considering a number of factors, such as traffic volumes and collision rates, in order to determine a priority for these projects. Those projects with the highest priority may be included in the next provincial construction program, again depending on funding availability. At this time, the paving of Highway 574 is identified as a future project that is outside the current three-year construction program.






