REPORT SUMMARY

The City of Airdrie reached out to Rocky View County (the County) in January to discuss potential involvement and interest in the development of their 185-acre regional park in northeast Airdrie. Airdrie may look for support from the County in the future, but at this stage, wanted to share their concept and request some initial feedback as to how this project might benefit County residents.

In the spirit of collaboration, the City of Airdrie is wanting to engage the County earlier in the process to invite feedback and keep the County informed on the progress. The 185-acre park was discussed at the March 5th IMC meeting and at the Governance meeting to invite feedback from our Council prior to the project being presented to the Airdrie City Council on March 18th. City staff are present to speak about the project and next steps.

ADMINISTRATION'S RECOMMENDATION

THAT the Governance Committee receives the City of Airdrie Regional Park Master Plan presentation as information.

BACKGROUND

In 2022, the City of Airdrie asked the regional community, which include County residents, what they would like to see in Airdrie's newest regional park through the Recreation Needs Assessment. Airdrie Council chose a theme of "Organized Sport and Civic/Events/Arts." The theme accommodates the need for sport amenities and an outdoor gathering space for the community.

DISCUSSION

The City of Airdrie has undertaken a master plan to guide the development of a new regional outdoor park, proposed to be located in the northeast portion of the city. The master plan will determine the park's full development through a phased approach with dependencies on infrastructure and budget. Public engagement for the master plan included an open call to the community including Rocky View County residents to participate in an open house to share their thoughts on the preliminary concept plan. Phase 1 of the park's development is scheduled to begin in Q3 2024, which may include pathways, washrooms, and picnic areas.

Ms. Justine Berger, Corporate Land Administrator and Mr. Stephen Utz, Director of the CAO Office, will present the master plan on their new regional park concept.







Phase 1A


- Upon Council's approval of the Master Plan, Phase 1 detailed design and construction tendering will commence.
- Construction to begin in Q3 2024 with Phase 1 scheduled to be open to the public in October 2024.
