



BYLAW C-8576-2024

A bylaw of Rocky View County, in the Province of Alberta, to amend Rocky View County Bylaw C-8097-2020.

WHEREAS Rocky View County Council is of the opinion that a revision to Bylaw C-8097-2020 is required to clarify the legal boundary of the portion of road being closed;

AND WHEREAS section 63(2)(g) of the *Municipal Government Act* permits changes to the substance of the bylaw to bring out more clearly what is considered to be the meaning of Bylaw C-8097-2020;

AND WHEREAS the Chief Administrative Officer of Rocky View County certifies that the proposed revisions have been prepared in accordance with Section 63(4) of the *Municipal Government Act* as amended from time to time;

Now therefore, the Council of Rocky View County enacts as follows:

Title

1 This bylaw may be cited as *Bylaw C-8576-2024*.

Definitions

2 Words in this Bylaw have the same meaning as those set out in the *Land Use Bylaw* and *Municipal Government Act* except for the definitions provided below:

- (1) **“Council”** means the duly elected Council of Rocky View County;
- (2) **“Land Use Bylaw”** means Rocky View County Bylaw C-8000-2020, being the *Land Use Bylaw*, as amended or replaced from time to time;
- (3) **“Municipal Government Act”** means the *Municipal Government Act*, RSA 2000, c M-26, as amended or replaced from time to time; and
- (4) **“Rocky View County”** means Rocky View County as a municipal corporation and the geographical area within its jurisdictional boundaries, as the context requires.

Effect

3 THAT Section 3 of Bylaw C-8097-2020 be revised as shown on the attached Schedule ‘A’ forming part of this Bylaw.

Effective Date

4 Bylaw C-8576-2024 is passed and comes into full force and effect when it receives third reading and is signed in accordance with the *Municipal Government Act*.

A PORTION OF THE ORIGINAL GOVERNMENT ROAD ALLOWANCE ADJACENT TO THE SOUTH WEST SECTION 21, TOWNSHIP 26, RANGE 3, WEST OF THE 5TH MERIDIAN, CONTAINING 1.38 HECTARES (3.4 ACRES) MORE OR LESS EXCEPTING THEREOUT ALL MINES AND MINERALS.

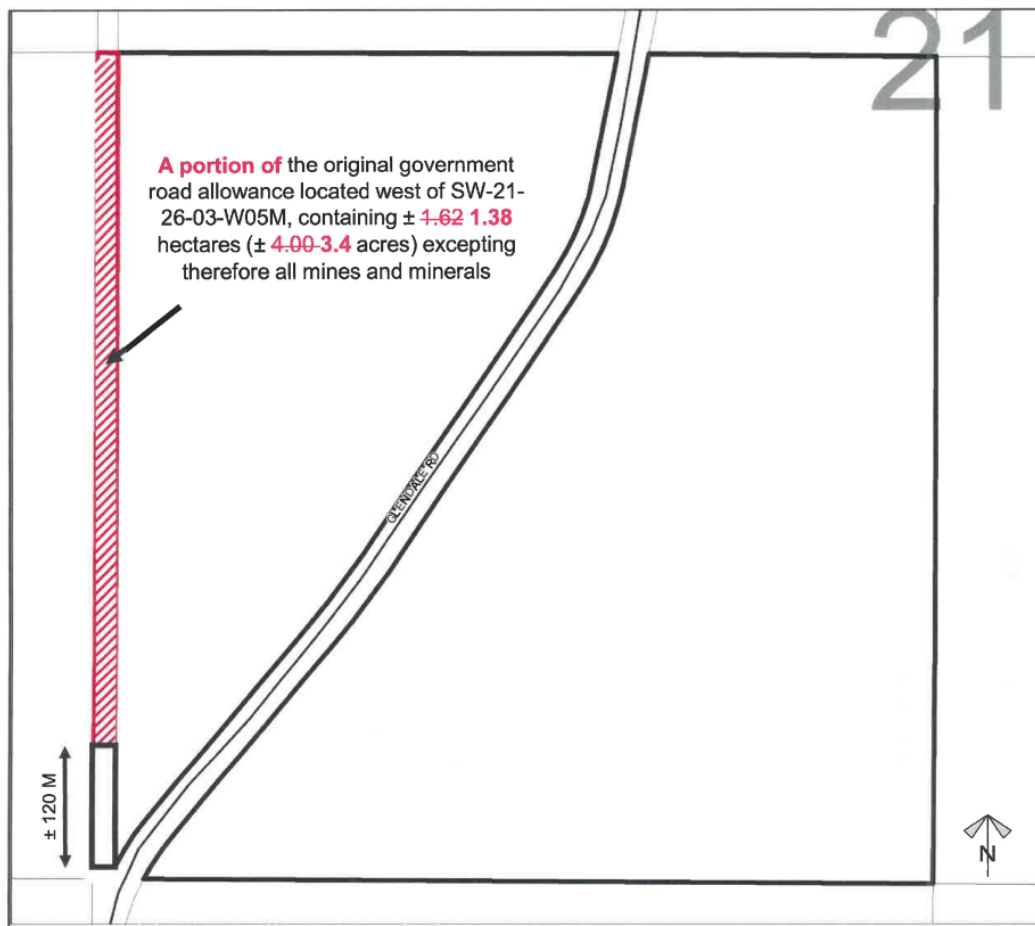
Revision 2: Replace the legal description within Section 3 with the following:

THE NORTHERNMOST 680 METER PORTION OF THE ORIGINAL GOVERNMENT ROAD ALLOWANCE ADJACENT TO THE SOUTH WEST SECTION 21, TOWNSHIP 26, RANGE 3, WEST OF THE 5TH MERIDIAN, CONTAINING 1.38 HECTARES (3.4 ACRES) MORE OR LESS EXCEPTING THEROUT ALL MINES AND MINERALS.



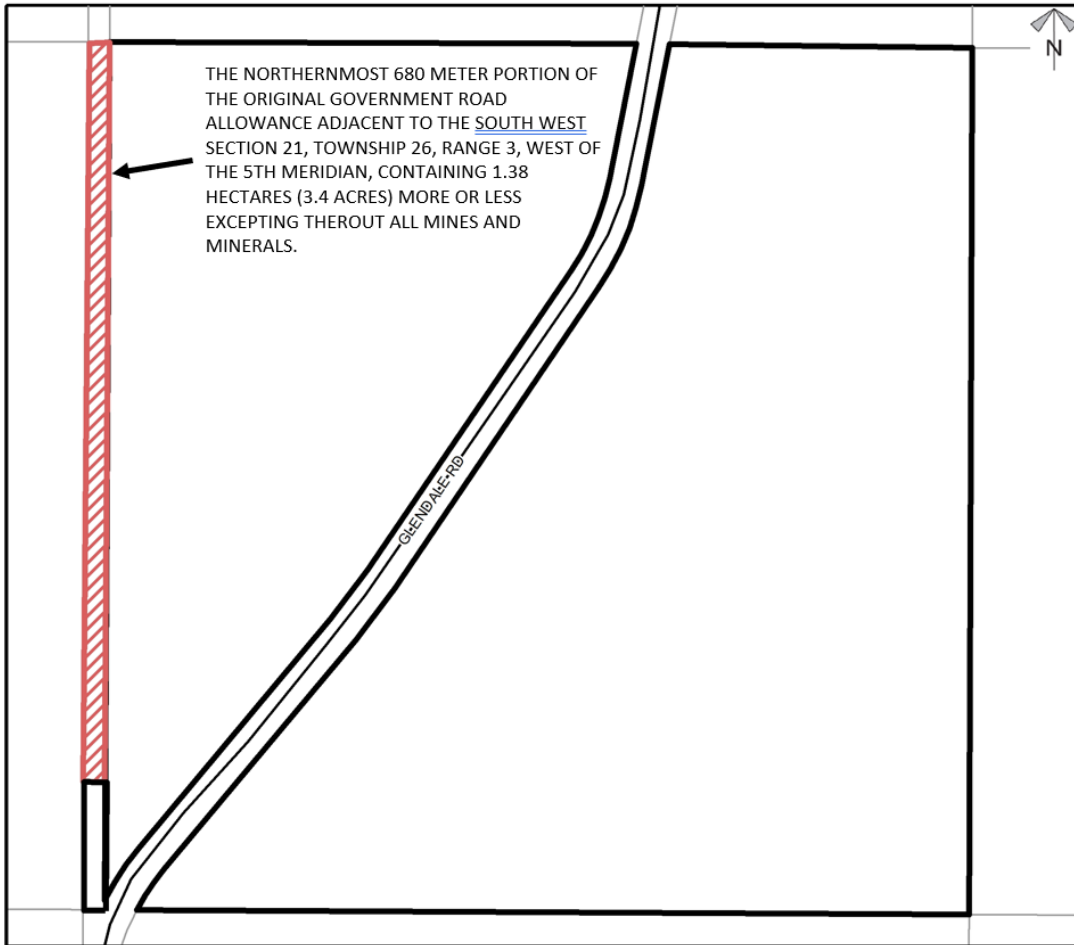
