• On page 1 in the Executive Summary section:

At the time of approval of these Terms of Reference, the County has indicated its intent to withdraw from the CMRB. This may result in uncertainty with respect to the ASP Bylaw approval process. The County's relationship with the City of Calgary may become more complex without the Growth Plan's guidance for regional considerations. With the rescindment of Growth Plan and Regional Evaluation Framework, the process for, and outcomes of, intermunicipal collaboration may be less clear.

• On page 8, in the Principal Project Risks section:

The County withdrawing from the CMRB may result in changes on the ASP approval process and may provide legislative uncertainty. With the rescindment of Growth Plan and Regional Evaluation Framework, the process for, and outcomes of, intermunicipal collaboration may be less clear.

Administration will monitor any updates released regarding the CMRB and will regularly report to Council, with early action being taken to rectify foreseen project delays. Administration will refer to the appropriate intermunicipal development plans for guidance; further, the engagement plan will include strategies for collaboration with intermunicipal partners, prioritizing early and frequent communication.

  - 3. The technical aspects of the subdivision proposal have been considered and are further addressed through the conditional approval requirements.
- B. The Applicant/Owner is required, at their expense, to complete all conditions attached to and forming part of this conditional subdivision approval prior to Rocky View County (the County) authorizing final subdivision endorsement. This requires submitting all documentation required to demonstrate each specific condition has been met, or agreements (and necessary securities) have been provided to ensure the conditions will be met, in accordance with all County Policies, Standards, and Procedures, to the satisfaction of the County, and any other additional party named within a specific condition. Technical reports required to be submitted as part of the conditions must be prepared by a qualified professional, licensed to practice in the province of Alberta within the appropriate field of practice. The conditions of this subdivision approval do not absolve an Applicant/Owner from ensuring all permits, licenses, or approvals required by Federal, Provincial, or other jurisdictions are obtained.



C. Further, in accordance with Section 654 and 655 of the *Municipal Government Act*, the application shall be approved subject to the following conditions of approval:

#### Survey Plans

- 1) Subdivision is to be effected by a Plan of Survey, pursuant to Section 657 of the *Municipal Government Act*, or such other means satisfactory to the Registrar of the South Alberta Land Titles District.
  - a) A Plan of Survey, including the Application number (PL20240115) and Roll number (04816001 & 04816002) of the parcels; and
  - b) Landowner's Consent to Register Plan of Survey.

#### Payments and Levies

2) The Owner shall pay the County Subdivision Endorsement fee, in accordance with the Master Rates Bylaw, for the boundary adjustment to create two (2) new titles.

#### **Taxes**

3) All taxes owing up to and including the year in which subdivision is to be registered, are to be paid to Rocky View County prior to signing the final documents pursuant to Section 654(1) of the *Municipal Government Act*.

#### **ADVISORY:**

• The Owner should prepare and register an access easement on each title, for the existing southern approach.
