SUBJECT: Harmony Conceptual Scheme Amendments

APPLICATION: Amendment to the Harmony Stage 3 Neighbourhood Plan (Harmony Conceptual Scheme, Appendix C) by placing an overlay onto each affected figure within the document identifying the overall stage area as either Stage 4 or Stage 5 to coincide with the proposed Stage 4 and Stage 5 Neighbourhood Plans.

GENERAL LOCATION: The Harmony Plan Area is located northwest of the Springbank airport, approximately one mile north of TWP RD 250 and adjacently east of RGE RD 40.

LAND USE DESIGNATION: Direct Control District (DC-129)

EXECUTIVE SUMMARY: Council gave first reading to Bylaw C-8154-2021 on April 13, 2021. The application is consistent with the relevant policies of the County Plan.

The proposal is to modify the existing Stage 3 plan area by removing areas of the proposed development and placing them within the newly proposed Stage 4 and Stage 5.

ADMINISTRATION RECOMMENDATION: Administration recommends approval in accordance with Option #1.

Motion #2 THAT Bylaw C-8154-2021 be given third and final reading.


POLICY ANALYSIS:

County Plan

The County Plan supports the development of the Hamlet of Harmony as a full-service community in accordance with the Conceptual Scheme. The proposed amendments to the conceptual scheme retain the mixed-use development concept.

Conceptual Scheme

The application proposes figure changes to the conceptual scheme to align with the proposed Stage 4 and Stage 5 Neighbourhood Plans. The proposed amendments do not change the intent of the document but rather the phasing; whereas, portions of Stage 3 will be shifted into the proposed Stage 4 or Stage 5 Plans as shown in the below figure:
