SUBJECT: Application Review - Cochrane Track & Field Association

POLICY DIRECTION:

The fall intake of applications are evaluated in accordance with Community Recreation Funding Policy C-317 and the Recreation and Parks Master Plan, Recreation Needs Assessment, Facility Development Criteria, and the Parks and Open Space Master Plan.

EXECUTIVE SUMMARY:

Cochrane Track & Field Association is submitting a late application to be considered by the Committee. The original application was received prior to the deadline date of October 1; however, the Association withdrew their application stating their \$1.2 million private donor withdrew their funding. After discussion with the Mayors of Cochrane and Rocky View County, the Association requests that the Committee reconsider their application of \$600,000 at this December 8, 2021, meeting.

ADMINISTRATION RECOMMENDATION:

Administration recommends refusal, in accordance with Option #1.

BACKGROUND:

At the Recreation Governance Committee meeting on June 2, 2021, the Committee made a motion that the *"Recreation Governance Committee refuse the capital funding request from the Cochrane Track & Field Association, and that the applicant be invited to reapply in the fall 2021 Community Recreation funding intake period with funding commitments from the Town of Cochrane and Rocky View Schools."*

During the fall community grant intake, Cochrane Track & Field Association submitted an application that was received prior to the deadline date of October 1; however, the Association withdrew their application stating their \$1.2 million private donation had been withdrawn. After a discussion with the Mayors of Cochrane and Rocky View County, the Association requested that the Committee reconsider their application of \$600,000 to support the construction of a multi-purpose outdoor artificial turf, at the December 8, 2021, meeting.

Cochrane Track and Field Association is undertaking a \$2.4 million-dollar multi-purpose artificial turf to replace the existing grass field that is located in the center of the tri-school site and Cochrane High School, which is owned by Rocky View Schools (RVS). The Association has an agreement with RVS with regard to the land being used to construct the multi-purpose field, and that RVS will maintain and operate the field for a period of no less than five years from the date of operation. The field will be accessible to the general public outside of school use through the RVS's booking system.

The Cochrane Track and Field Association have not confirmed matching funding from the Town of Cochrane, but have a letter of support, which states the funding contribution to this project will be added to the Town of Cochrane's 2022 budget deliberations.



Administration assessed the application based on amenities in the region, vetted through the County's 2020 Recreation Needs Assessment, Recreation Master Plan, Facility Development Criteria and Parks and Open Space Master Plan, which indicates that the area is over-serviced with outdoor amenities in the region, and therefore, for our residents, there is no indication of a need for an additional outdoor artificial turf.

Current amenities located within the region include an indoor turf at the Spray Lake Sawmills Family Sports Centre and an outdoor turf at Bow Valley High School, both which are located in Cochrane and have received County funding. There is also a privately owned turf at the Edge School, located in Springbank.

Future identified amenities within the region are Horse Creek Park, located in the town of Cochrane, which will consist of four outdoor fields and ball diamonds, and Webber Academy with four outdoor ball diamonds and indoor fields located in Springbank.

Based on this assessment, Administration would not recommend funding as:

- 1. There is no confirmation of matching funding from the Town of Cochrane.
- 2. The project is not identified in our Recreation, Parks Master Plan.
- 3. The project is not identified as a recreational need for our residents, based on current and future amenities.

BUDGET IMPLICATIONS:

If funding is approved, it would be taken from the County's Public Reserve, which currently holds just over \$7,000,000.

OPTIONS:

- Option #1 THAT the capital funding request from the Cochrane Track & Field Association up to \$600,000 be refused, as this project does not meet criteria in Policy C-317.
- Option #2 THAT the capital funding request from the Cochrane Track & Field Association up to \$600,000 be supported, pending confirmation of matching funding from the Town of Cochrane.

Option #3 THAT alternate direction be provided.

To build, maintain and operate a multi-purpose artificial turf field for recreational and community purposes. To ensure the facility is available for public use. To stimulate local economic activity. This inclusive facility will improve community health and well-being by providing a public space where people of all ages, abilities, colour, gender identity and/or expression, national origin, race,

sex, and sexual orientation can come together, build physical literacy skills, play athletic games, and enable community development.

Please describe in detail the work to be carried out and the need for this project: (Please attach a separate piece of paper if you need additional space)

The existing grass field is located in the center of the Tri-school site: Cochrane High School (882 students); Ecole Manachaban Middle School (447 students), and Elizabeth Barrett Elementary (517 students). These schools are a part of the Rocky View School Division. The current field is a typical Alberta outdoor school field - barely visible chalk lines, uneven and with an intermix of grass patches, exposed soil, and gopher holes. Grass fields are known to be unsafe for athletes, resulting in many preventable injuries. The Cochrane High School football team has deemed it to be so unsafe, that they hold all of their practices and games at Bow Valley High School (6.3 km away) which has a well marked artificial turf field. The existing Tri-school site is so unsafe that it is not booked by any football, soccer or rugby clubs. An artificial turf field has *five times as many playable hours per year* than a grass field, so weather does not become an impediment to the game or PE classes. Artificial turf fields do not require watering, herbicides, pesticides or remarking of chalk lines. This multi-purpose field will also be used for football, soccer, rugby, ultimate frisbee, and multi-cultural community events.

Giving students (and adults) an opportunity to train on a facility that is safe and designed for these activities is crucial. This is a key step in keeping everyone healthy and enthusiastic about exercise and the important socialization which will occur. This large outdoor facility will have lots of permanent seating and state of the art outdoor lighting which will also allow this facility to be used in the evening, especially in the fall and spring when there are less daylight hours. RVS will allow users to use the school and large school bus parking lot in the non-school hours for parking. Over 400 spots.

We have strong community support, as evidenced by the over 20 support letters attached. We have met with the Community members twice, via zoom, and we will continue to meet with Community members to address their concerns and to get their feedback. Fund-raising for this project has already started and will continue until the goal of \$2.4 million is raised. We have a great start with the large private donation of \$1.2 million (commitment letter available upon request). We also have another private donation of up to \$100,000, which is a matching donation to any other donations received for this project. The Town of Cochrane Council Members have reviewed our project and have committed, in writing, to consider funding up to \$600,000 from their 2022 Capital Budget, which will happen in November/December 2021. We have started discussions with potential private and corporate donors.. A grass-roots fund-raising campaign will be started as well. NAX Design Strategies, who are very experienced in this type of work, will be our Primary Consultant and they will work in consultation with Rocky View Schools, who will oversee the construction of this project. Our major donor and President, have both overseen large construction projects and they will also be actively involved.

Please describe the methodology used to quantify this number:

Maximum number-59,467-Rocky View County census numbers - 25,000 in the western half of RVC+34,467 (town of Cochrane) = . Everyone in the this area will have access to the facility via the RVS on-line booking system

Expected numbers-There are 1,846 students at the 3 schools on the site and they will use the facility at least once per week. $\frac{3}{3}$ of the students are from Cochrane and $\frac{1}{3}$ are bussed in from rural areas. Cochrane Lions Football Club has- 100 players ;Bow Valley Rugby Club has 400 players; Cochrane Minor soccer has 800 players; Ultimate frisbee -30 .Total=3,176.

With 3,176 children involved in sporting clubs and events. We would expect at least 3 family members/friends to come out watch each participant = 9,528 + teachers (100), coaches (240) and adult soccer, rugby and ultimate frisbee teams (500). Total RVC users = 10.368

The CHS football team will now be able to host 8 home games per year and those players and their parents from Calgary will add another **1760** visitors. – 8 games*55 visiting players*2 spectators.

Describe how the project will benefit your community and the County:

Everyone in the Rocky View County and visitors from outside the County will benefit from this well-designed multi-purpose facility, either as a participant in an activity or as a fan watching a family member or friend performing. RVC students will have a huge benefit of being able to train and play on a safe artificial field. An artificial field provides *5 times as many usable hours over a grass field*. This will help the students achieve the 30 minutes of activity they should have every day while at school. The CHS football team will no longer have to incur the time and cost of bussing to Bow Valley High School for practices and games. The current grass field is not booked by after school groups as it is too dangerous for them to use. User groups (like track and field, soccer, rugby, football, ultimate) will now have an additional artificial field to safely play on. During non-school hours this facility will be available for the public to book via the Rocky View School Division online booking system. Community involvement and volunteering will be encouraged. Cochrane and Rocky View County will see positive direct economic benefits, during construction and indirect financial benefits (meals, hotels, etc.) when the field is booked for training, games and tournaments.

All RVC residents will have equal access to this facility. As the facility is on Rocky View School Division 41 land, they will have control of the allocation of time during school hours (1200 hours) to their various schools. The Society will assist RVS in the allocation of the remaining 1800 hours of non-school time bookings. The plan is to share the facility, equitably, with as many different user groups as possible from Rocky View County and the Town of Cochrane. The goal will be to give as many different people and groups access. See RVS letter attached with the terms of their support.

As the Cochrane Track and Field Association is only newly formed, there are no excess funds presently. Our private alumni door donated \$5000 to cover our start up costs and D&O insurance. All bookings will be managed, and the money will be retained, by RVS. RVS is responsible for the operations, maintenance and long term costs of resurfacing the turf field in 10-15 years. Any future excess operating funds will be added to the Capital Reserve for the resurfacing of the artificial turf field.

If you are unsuccessful in getting approved for the total amount of funds requested, how do you plan on completing the project?

We will continue with our fund-raising efforts to complete the entire project. We are actively pursuing other private and corporate donors (including in-kind donations) and we are waiting for the Town of Cochrane's capital budget allocation. We will also apply for a capital grant from CFEP and other smaller grants.

We are waiting for the Town of Cochrane to complete (late 2021) their 2022 Capital Budget Allocation (\$600,000 max ask). We will submit an application by January 15th, 2022 for the CFEP (\$125,000) grant. As well we will apply for the Co-op Community spaces Funding(\$150,000) and we will apply for the Cochrane Community Capital Grant (\$5000) and the Canada Post grant (\$5000). Our team continues to source out other grants to which we will apply.
