

BYLAW C-8279-2022

A Bylaw of Rocky View County, in the Province of Alberta, to amend the Chief Administrative Officer Bylaw and repeal the Development Authority Bylaw.

WHEREAS section 191 of the *Municipal Government Act* allows Council to amend and repeal bylaws;

NOW THEREFORE the Council of Rocky View County enacts as follows:

Title

1 This bylaw may be cited as Bylaw C-8279-2022.

Definitions

- Words in this bylaw have the same meaning as those set out in the *Municipal Government Act*, except as follows:
 - (1) "Chief Administrative Officer Bylaw" means Rocky View County Bylaw C-7350-2014, being the Chief Administrative Officer Bylaw, as amended or replaced from time to time;
 - (2) "Development Authority Bylaw" means Rocky View County Bylaw C-4549-95, as amended or replaced from time to time; and
 - (3) "Municipal Government Act" means the Municipal Government Act, RSA 2000, c M-26, as amended or replaced from time to time.

Effect

- Rocky View County Bylaw C-7350-2014, being the *Chief Administrative Officer Bylaw*, be amended as set out within Schedule 'A' attached to and forming part of this bylaw.
- 4 Rocky View County Bylaw C-4549-95, being the *Development Authority Bylaw*, and all amendments thereto are repealed upon this bylaw passing and coming into full force and effect.

Severability

If any provision of this bylaw is declared invalid for any reason by a court of competent jurisdiction, all other provisions of this bylaw will remain valid and enforceable.

- 3.4.34 Fulfill the duties, responsibilities, and authority of the Subdivision Authority in accordance with the Municipal Government Act and the County's Subdivision Authority Bylaw C-8279-2022, as amended or replaced from time to time.
- 3.4.35 Fulfill the duties, responsibilities, and authority of the Development Authority in accordance with the Municipal Government Act and the County's Land Use Bylaw C-8000-2020, as amended from time to time.
