

BYLAW C-8293-2022

A Bylaw of Rocky View County, in the Province of Alberta, to Revise Road Closure Bylaw C-8143-2021.

WHEREAS Rocky View County Council is of the opinion that a revision to Bylaw C-8143-2021 is required to clarify the legal description of the portion of road being closed;

AND WHEREAS section 63(2)(g) of the *Municipal Government Act* permits changes to the substance of the bylaw to bring out more clearly what is considered to be the meaning of Bylaw C-8143-2021;

AND WHEREAS the Chief Administrative Officer of Rocky View County certifies that the proposed revisions have been prepared in accordance with Section 63(4) of the *Municipal Government Act* as amended from time to time.

NOW THEREFORE the Council of Rocky View County enacts as follows:

1 THAT the legal description in Section 3.1 of Bylaw C-8143-2021 is revised as follows:

FROM:

A PORTION OF THE ORIGINAL GOVERNMENT ROAD ALLOWANCE EAST OF THE NORTHEAST SECTION 03, TOWNSHIP 24, RANGE 03, AND WEST OF THE 5TH MERIDIAN, AND EAST OF THE SOUTHEAST SECTION10, TOWNSHIP 24, RANGE 03, AND WEST OF THE 5TH MERIDIAN, CONTAINING 1.21 HECTARES (3.00 ACRES) MORE OR LESS EXCEPTING THEREOUT ALL MINES AND MINERALS.

TO:

ALL THAT PORTION OF THE ORIGINAL GOVERNMENT ROAD ALLOWANCE ADJACENT TO THE SOUTH EAST QUARTER SECTION 10, TOWNSHIP 24, RANGE 3, WEST OF THE FIFTH MERIDIAN AND THE NORTH EAST QUARTER SECTION 3, TOWNSHIP 24, RANGE 3, WEST OF THE FIFTH MERIDIAN WHICH LIES WITHIN AREA 'A' ON PLAN _______, CONTAINING 0.944 HA (2.33 ACRES) MORE OR LESS EXCEPTING THEREOUT ALL MINES AND MINERALS

AND

ALL THAT PORTION OF THE ROAD WIDENING SHOWN ON SUBDIVISION PLAN 7510835 WHICH LIES WITHIN AREA 'A' ON PLAN ______, CONTAINING 0.243 HA (0.60 ACRES) MORE OR LESS EXCEPTING THEREOUT ALL MINES AND MINERALS

- 2 THAT Bylaw C-8143-2021 be revised by replacing Schedule 'A' of the bylaw with Schedule 'A' of this bylaw, being Bylaw C-8293-2022.
- 3 Bylaw C-8293-2022 is passed and comes into force and effect when it receives third reading and is signed in accordance with the *Municipal Government Act*.
