

# **BYLAW C-8280-2022**

# A bylaw of Rocky View County, in the Province of Alberta, to amend Direct Control District 99 (DC-99, Bylaw 6031-2005)

The Council of Rocky View County enacts as follows:

### Title

1 This bylaw may be cited as *Bylaw* C-8280-2022.

### Definitions

- 2 Words in this Bylaw have the same meaning as those set out in the Direct Control District (DC-99, Bylaw C-6031-2022), *Land Use Bylaw* and *Municipal Government Act* except for the definitions provided below:
  - (1) "Council" means the duly elected Council of Rocky View County;
  - (2) "*Land Use Bylaw*" means Rocky View County Bylaw C-8000-2020, being the *Land Use Bylaw*, as amended or replaced from time to time;
  - (3) "*Municipal Government Act*" means the *Municipal Government Act,* RSA 2000, c M-26, as amended or replaced from time to time; and
  - (4) **"Rocky View County"** means Rocky View County as a municipal corporation and the geographical area within its jurisdictional boundaries, as the context requires.

#### Effect

- 3 THAT Direct Control District 99 (DC-99, Bylaw C-6031-2005) be amended as detailed in Schedules 'A' attached to and forming part of this Bylaw.
- 4 THAT Schedule B, Land Use Maps, of Bylaw C-8000-2020 be amended by redesignating Lots 1 and 2, Block 1, Plan 1611567 within NW-10-26-29-W04M from Direct Control Bylaw 99 (DC-99, Bylaw C-6031-2005) to Direct Control Bylaw 99 (DC-99, Bylaw C-6031-2005), as amended, as shown on the attached Schedule 'B' forming part of this Bylaw.

#### **Effective Date**

5 Bylaw C-8280-2022 is passed and comes into full force and effect when it receives third reading and is signed in accordance with the *Municipal Government Act*.

## SCHEDULE 'A' FORMING PART OF BYLAW C-8280-2022

Schedule of Amendments to Bylaw C-6031-2005:

1. Amend Section 3.14.0 to add:

3.14.0 Site Coverage

(iv) Notwithstanding Section 3.14.0, the Maximum Site Coverage for a portion of NW-10-26-29-W4M as shown on Schedule 'D' is 40%

2. Amend Section 2.3.0 to read:

#### 2.3.0 Cell A – List of Uses

- 2.3.18 The following additional uses are allowed within a portion of NW-10-26-29-W4M as shown on Schedule 'D':
  - Animal Health Services, small animal; Banks or Financial Institutions; Convenience Store; Drinking Establishment; General Store; General Stores, Local; Grocery Stores, Regional; Liquor Sales; Restaurant; Retail Food Store; Patio, accessory to the principal business use; Service Station; and Specialty Food Store.
