



ROCKY VIEW COUNTY

BYLAW C-8344-2022

A bylaw of Rocky View County, in the Province of Alberta, to amend Rocky View County Bylaw C-8000-2020, being the *Land Use Bylaw*.

The Council of Rocky View County enacts as follows:

Title

- 1 This bylaw may be cited as *Bylaw C-8344-2022*.

Definitions

- 2 Words in this Bylaw have the same meaning as those set out in the *Land Use Bylaw* and *Municipal Government Act* except for the definitions provided below:
- (1) **“Council”** means the duly elected Council of Rocky View County;
 - (2) **“Land Use Bylaw”** means Rocky View County Bylaw C-8000-2020, being the *Land Use Bylaw*, as amended or replaced from time to time;
 - (3) **“Municipal Government Act”** means the *Municipal Government Act*, RSA 2000, c M-26, as amended or replaced from time to time; and
 - (4) **“Rocky View County”** means Rocky View County as a municipal corporation and the geographical area within its jurisdictional boundaries, as the context requires.

Effect

- 3 THAT Schedule B, Land Use Maps, of Bylaw C-8000-2020 be amended by redesignating NW-31-24-28-W04M; Plan 9011064, Lot 1; and Plan 0812829 all within NW-31-24-28-W04M from Agricultural, General District (A-GEN) to Business, Regional Campus District (B-REG), Industrial, Light District (I-LHT), Special, Natural Open Space District (S-NOS), Special, Parks and Recreation District (S-PRK), and Special, Public Service District (S-PUB) as shown on the attached Schedule 'A' forming part of this Bylaw.
- 4 THAT NW-31-24-28-W04M; Plan 9011064, Lot 1; and Plan 0812829 all within NW-31-24-28-W04M is hereby redesignated to Business, Regional Campus District (B-REG), Industrial, Light District (I-LHT), Special, Natural Open Space District (S-NOS), Special, Parks and Recreation District (S-PRK), and Special, Public Service District (S-PUB) as shown on the attached Schedule 'A' forming part of this Bylaw.

Effective Date

- 5 Bylaw C-8344-2022 is passed and comes into full force and effect when it receives third reading and is signed in accordance with the *Municipal Government Act*.
