SUBJECT: Capital Project Update

EXECUTIVE SUMMARY:

The purpose of this report is to provide Council with an update on various Capital Projects that are currently underway or have recently been completed in the County.

The core function of the Capital Project team is to deliver projects which result in a new or improved tangible capital asset. This includes the engineering and construction of County infrastructures such as roads, water, wastewater, stormwater, buildings, and recreation facilities.

Council has approved significant resources and funding towards 27 major capital projects, 17 of which were approved for 2022 that have a total value of approximately \$121-million dollars. Major capital projects are funded through a combination of Levies, Federal and Provincial Grants, Cost Sharing Contribution Agreements, Local Improvement Tax and/or Taxes. Administration continually looks to maximize the available Federal and Provincial Grants and other sources to ensure that the tax-funded portion by the County residents and businesses is minimized as much as possible. The process of landowner consultation, land acquisition and regulatory approval will typically contribute to the complexity of the project and influences the project schedule, which results in projects extending over multiple years to reach completion. A summary of all the approved projects is included in Attachment 'A' of the report along with the approved budget and the funding sources previously approved.

Seven out of the ten projects approved in prior years are substantially complete except for the Dalroy Drainage improvement and Pinebrook Stormwater Diversion which are experiencing delays and challenges due to land acquisition and Water Act approval. The West Balzac Servicing extension is currently on schedule with the construction of the Sanitary Lift Station currently underway. The approved 2022 projects are in various stages of engineering, construction tender or construction, all of which are anticipated to be on track for budget and schedule.

ADMINISTRATION RECOMMENDATION:

Administration recommends approval in accordance with Option #1.

BACKGROUND:

Council approves major capital projects annually as part of the budgeting process or throughout the year as necessary. This report provides a status update on the major capital projects currently underway or recently completed under the Capital Projects department. The department ensures that capital projects approved by Council are delivered on budget, on schedule and in accordance with all applicable engineering, environmental and legislative requirements. There are ten projects that was approved prior to 2022, many of which has been completed or substantially complete awaiting minor warranty work and close out documentation. The approved 2022 projects are in various stages of engineering, construction tender or construction, all of which are anticipated to be on track for budget and schedule.
